USA: New \$2 billion deal for Bayer to get out of future pesticide litigation

Following the avalanche of lawsuits from non-Hodgkin's lymphoma (NHL) patients due to their use of Roundup herbicide, and the recognition in the first 3 cases of the liability and malice of Monsanto, the company producing these glyphosate-based herbicides, Bayer, has proposed a \$11 billion settlement to resolve pending lawsuits (except for the three already tried, for which Bayer has appealed).

PHYTOPHAR against Walloon Region: Banning pesticides is forbidden!

On January 21, 2021, Belgium's Council of State cancelled the Walloon Region's March 2017 order banning the use of glyphosate-based herbicides in the region. According to the Council of State, the ban on glyphosate-based herbicides ordered by the Walloon Region is too general and set for too long a period, which makes the order illegal.

Rollback of farm worker protection against pesticides challenged in court

The U.S. Department of the Environment (EPA) has made a number of legislative rollbacks and exemptions on pesticides under President Donald Trump. It has refused to ban chlorpyrifos, a pesticide suspected of damaging children's brains, allowed the herbicide dicamba to be used on GMO crops despite damage to surrounding crops due to its drift, renewed the approval of glyphosate-based herbicides despite thousands of complaints from users with non-Hodgkin's lymphoma, etc.

Neonicotinoids in courts!

Justice Pesticides has produced, with the financial support of the Greens/EFA group in the European Parliament, a summary of court cases involving neonicotinoid pesticides in Europe and around the world.

Widely used since the 1980s and 1990s, neonicotinoids are extremely toxic insecticides in infinitesimal doses. In spite of their danger to the environment and living species, documented as soon as they were put on the market, it took two decades before the first prohibition measures appeared, particularly in the European Union, and they continue to be used massively on all continents, generating legal action, both by environmental associations and beekeepers to prevent their use, and by agrochemical companies to challenge their prohibition or the limits on their use.




